ORDINANCE NO. 985-XIII

AN ORDINANCE ADOPTING THE CITY OF HUNTERS HOLLOW, KENTUCKY BUDGET FOR THE FISCAL YEARS OF JULY 1, 1983 THROUGH JUNE 30, 1985, BY ESTIMATING REVENUE AND RESOURCES AND APPROPRIATIONS OF FUNDS FOR THE OPERATING OF CITY GOVERNMENT.

WHEREAS, an annual budget proposal and message has been prepared and delivered to the City Council; and

WHEREAS, the City Council has reviewed such budget proposal and made necessary modifications.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, as follows:

SECTION ONE: That the budget for the Fiscal Years beginning July 1, 1983 and ending June 30, 1985 is hereby adopted as follows:
