

ORDINANCE NO. 985-94

AN ORDINANCE AMENDING BUDGET FOR THE FISCAL YEAR JULY 1, 1995, THROUGH JUNE 30, 1996.

WHEREAS, on the 20th day of June, 1995, the City Council of the City of Hunters Hollow did adopt Ordinance No. 985-87 an ordinance adopting City of Hunter Hollow, Kentucky, annual budget for fiscal year July 1, 1995, through June 30, 1996, and,

WHEREAS, it is now necessary to amend said budget to more accurately reflect the revenues received and the expenditures made, now, therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUNTERS HOLLOW, as follows:

SECTION I: That the annual budget for the fiscal year beginning July 1, 1995, and ending June 30, 1996, is hereby readopted as follows:
