## MINUTES REGULAR CITY COMMISSIONER'S MEETING JANUARY 22, 2019 7PM

Quorum Determined and Meeting called to order at 7pm by Mayor Ross

Commissioner MacIntyre nominated Bonnie Israel to serve as Commissioner.

City Attorney swore in Bonnie Israel as Commissioner.

Commissioner Israel made a motion to accept the minutes for November 16, 2018. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

Commissioner MacIntyre made a motion to accept the Financial Report from November 2018. Commissioner Israel 2<sup>nd</sup> the motion. All were in favor. Motion carried.

No minutes from December 2018 due to no meeting.

Commissioner Israel made a motion to accept the Financial Report from December 31, 2018. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

Commissioner Israel nominated David Lotze to serve as Commissioner. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

City Attorney swore in David Lotze as Commissioner.

### OLD BUSINESS

Mayor Ross discussed the 99 Dodge Truck did not meet the reserve of \$1200 on GovDeals so it was lowered to \$900 and sold for \$1034 on January 14, 2019.

### NEW BUSINESS

Mayor Ross discussed putting the Garbage Service out for bid. The Mayor and several residents have complained about the price of service. Attorney Edison will place ad in the Pioneer News.

City Clerk McCauley asked the Commissioner's for an internet allowance of \$50. Commissioner Lotze made a motion to provide the City Clerk a monthly internet allowance of \$50 starting January 2019. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

### COUNCIL BUSINESS

The Commissioner's discussed the purchase of new City of Hunters Hollow signs and poles.

Mayor Ross explained the Contract for Plowing Snow by the City of Hillview.

### POLICE BUSINESS

Newly elected Constable Larry Watkins spoke about how he can write citations from his book, and monies would be collected by Bullit County to go to the State NOT the City of Hunters Hollow. Constable Watkins suggested the Code Enforcement Officer for Hillview, Eddie McAlister as a possible solution. Commissioner MacIntyre recommends the City keep the Police Protection as is.

### PUBLIC BUSINESS

Water pooling on Angelina Road before drain, fixed by Louisville Water Company is still an issue according to homeowner.

Easement's being graveled for parking by residents is still an issue. Need RLH Rentals to provide a quote to remove gravel and restore at 3708 Arcadia Court.


**ADJOURNMENT**
