## MINUTES REGULAR CITY COMMISSIONERS MEETING OCTOBER 16, 2018 7PM

Meeting Called to order by Mayor Ross at 7pm

Clerk McCauley read the minutes from September 18, 2018.  
Commissioner MacIntyre made a motion to accept the minutes for September 18, 2018. Commissioner Lotze 2<sup>nd</sup> the motion. All were in favor. Motion carried.  
Commissioner Lotze made a motion to accept the Financial Report from September 2018. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

Attorney Edison explained the Municipal Road Aid Fund and what the City can and cannot use money for, a few examples given were the paving of roads, bridges and road work

No public showed up for the Public Hearing on 2018 Tax Rates.

### OLD BUSINESS

The City received a quote from Hester's Lawn Service after the meeting adjourned to clean the creek area by the end Blue Lick Road (common area). The estimate is to remove three trees, remove brush and drudge the ditch from end to end, for a total of \$1050.00. Commissioner Lotze made a motion to accept the quote from Hester's Lawn Service to clean the ditch area from end to end with the provision the City received the quote. Commissioner Israel 2<sup>nd</sup> the motion. All were in favor. Motion carried.

Commissioner Lotze made a motion to sell the 60 bags of salt with no reserve on GovDeals, due to reserve not being met during the auction on GovDeals. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.

Mayor Ross is waiting on the City of Hillview to provide the interlocal agreement for snow removal for Hunters Hollow. 5

Clerk McCauley will order new citation books for the parking ordinance. Attorney Edison advised the Commissioners and Mayor they need to determine who will issue the citations. Also, when needed the vehicles in violation will be towed by and to Troy's Wrecker Service (impound lot).

The Mayor discussed her verbally abusive dealings from a resident and her young daughter riding an ATV and tearing up the ground in the common area in which the Mayor was recording. Attorney Edison advised Officer Hibbs to issue the mother a citation.

A resident on Angelina Rd has raw sewage in basement. Resident called Bullitt County Sanitation only to be told they could not help her. Attorney Edison will call County Attorney to work with Bullitt County Sanitation to resolve this matter.

A resident on Canon Ct is looking to extend a privacy fence in side yard. Attorney Edison will look up the subdivision restrictions and send to the Mayor.
