Attorney Edison states it would cost the City \$120.00 per house or \$60 per person plus one filing fee to file suit. Commissioner MacIntyre made a motion for Mark Edison to send final notice to residents to remove concrete / gravel from easement. If no response within 30 days, the City would file a combined suit on all residents. Commissioner Lotze 2nd the motion. All were in favor. Motion carried.

PUBLIC BUSINESS


