Minutes Regular City Council Meeting April 20, 2021, 7:00PM

In Attendance Mayor Ross, Clerk McCauley, City Attorney Edison and Commissioners: Israel and Lotze. MacIntyre.

Quorum determined and meeting called to order at 7:00pm by Mayor Ross

- ✚ Clerk McCauley read the meeting minutes from March 16, 2021. Commissioner Lotze made a motion to accept the regular minutes as read from March 16, 2021. Commissioner MacIntyre 2nd the motion. All were in favor. Motion carried.
- ✚ Clerk McCauley read the financial report from March 31, 2021. Commissioner MacIntyre made a motion to accept the financial report for March 31, 2021. Commissioner Lotze 2nd the motion. All were in favor. Motion Carried.



OLD BUSINESS

- ✚ Mayor Ross has received complaints about dogs running free in the neighborhood, basketball goals and parking. Attorney Edison stated to call Bullitt County Animal Control for animal complaints, if basketball goals are in the street get a tow truck to tow it. There is no Constable to inform anyone of parking issues.

NEW BUSINESS

- ✚ Attorney Edison opened bids for the 2020 Delinquent Tax Sale. No bids were given. Commissioner Israel made a motion for the City to purchase the 2020 delinquent taxes for the City of ^H Hunters Hollow. Commissioner MacIntyre 2nd the motion. All were in Favor. Motion Carried.
- ✚ First reading of Ordinance 2021-01 Insurance Tax Premium. Attorney Edison states that the City will raise their part of taxes to 10% effective ~~2022~~ ²⁰²¹. Attorney Edison states that paperwork must be filed before July 1, 2021.
- ✚ Attorney Edison states that if the City wishes to hire off duty officers for police protection in the City they must do so and sign a contract before July 1, 2021 to receive HB-413 monies from the state.



COUNCIL BUSINESS

- ✚ Attorney Edison gave an update on Bullitt County Sanitation and MSD. He said they are working in stages to come to an agreement. Part of the agreement states that sewer rates for January 1, 2022 will increase 40% each calendar year thru 2026 then 3% thereafter until equal to the rates in Jefferson County ✓




ADJOURNMENT

 Commissioner Lotze made a motion to adjourn the meeting. Commissioner Israel 2nd the motion. All were in favor. Motion Carried.




