Quorum determined and meeting called to order at 7:00pm by Mayor Ross

- ✚ Clerk McCauley read the meeting minutes from May 18, 2021. Commissioner Lotze made a motion to accept the regular minutes as read. Commissioner Israel 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- ✚ Clerk McCauley read the financial report from May 30, 2021. Commissioner MacIntyre made a motion to accept the financial report from May 30, 2021. Commissioner Lotze 2<sup>nd</sup> the motion. All were in favor. Motion Carried.




## ADJOURNMENT
