

ORDINANCE NO. 2020-05

AN ORDINANCE AMENDING THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2019, THROUGH JUNE 30, 2020.

WHEREAS, on the 18th day of June, 2019, the City Council of the City of Hunters Hollow did adopt Ordinance No. 2019-02 AN ORDINANCE ADOPTING CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY, ANNUAL BUDGET FOR FISCAL YEAR JULY 1, 2019, THROUGH JUNE 30, 2020, and
