Quorum determined and meeting called to order at 7:00pm by Mayor Ross

- ✚ Clerk Steele read the meeting minutes from July 20, 2021. Commissioner Lotze made a motion to accept the regular minutes as read. Commissioner MacIntyre 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- ✚ Clerk Steele read the financial report from July 31, 2021. Commissioner MacIntyre made a motion to accept the financial report from July 31, 2021. Commissioner Lotze 2<sup>nd</sup> the motion. All were in favor. Motion Carried.

- ✚ Attorney Edison read 1<sup>ST</sup> Reading of Ordinance 2021-04 Personal Property AdVal Tax.
- ✚ Attorney Edison read 1<sup>ST</sup> Reading of Ordinance 2021-05 Public Service Co. AdVal Tax.
- ✚ Mayor Ross asked the Commissioners which day would be best for a Special Meeting for the 2<sup>nd</sup> reading of the tax ordinances. It was decided August 30<sup>th</sup> at Pioneer Village at 7pm.

## COUNCIL BUSINESS

- ✚ Attorney Edison said Commonwealth Bank and Trust was purchased by Stock Yards Bank.
- ✚ Attorney Edison said the American Rescue Plan Act monies can be spent on things like additional Policing for gun violence, stormwater drainage repair, sewers may enter into an agreement with MSD to fix underground pipes that have collapsed, premium pay for essential workers. A tentative plan for usage of money is due by October 31, 2021.
- ✚ Commissioner MacIntyre said he is looking into the house that is allegedly running an Eldercare Program seen on the Next Door App.
- ✚ Mayor Ross asked the Clerks to get estimates for striping the crosswalk by MHS.

## ADJOURNMENT




