NEW BUSINESS

- ✚ Mayor Ross asked if anyone wished to bid on the 2021 Delinquent Taxes, parcel number 043-NW0-21-027. With no responses, Commissioner Shawn MacIntyre made a motion to have the City purchase the 2021 delinquent taxes for parcel number 043-NW0-21-027 for a total \$732.77. ^{2nd?}
- ✚ Mayor Ross discussed the oil spill at 3705 Balboa Pl which spilled into their yard and two other neighbor's yard. The fire department responded to the house placing stuff down to absorb the oil in all the yards. EMA also responded. The homeowner at 3705 Balboa Pl dug out the soil at 3707 Balboa Pl and replaced with gravel and is parking on the spot. Mayor Ross showed pictures of spill to Attorney and Commissioners and asked City Attorney Mark Edison to send a letter to the homeowner to remove the gravel. Also, Mayor Ross asked that a letter will be sent to EMA for questions on the proper cleanup of the property.



COUNCIL BUSINESS

- ✚ Commissioner MacIntyre expressed concerns on the property behind his house across the creek is up for sale and he was told it was going to be used for a parking lot for big trucks. The Commissioner would like a barrier placed between the properties.
- ✚ Commissioner Israel would like to raise the pay for Hester's Lawn Service. She said he has been paid the same for several years and does extra services for the City all the time without charges. Commissioner Israel made a motion to increase the amount of pay per cut by \$50.00. Commissioner MacIntyre 2nd the motion. All were in favor. Motion carried.
- ✚ Commissioner MacIntyre said the company who did the snow removal for the City has decided to donate their time and services to the City of Hunters Hollow.
- ✚ Commissioner MacIntyre is still gathering information for the estimates on drainage for the City.
- ✚ Commissioner Israel is requested a parking permit from the City Clerk for some time in June for a party she will be hosting.



POLICE BUSINESS

- ✚ Mayor Ross reported Detective Witherspoon issued an ordinance violation citation for parking on the street to resident on Arbor Trace.



PUBLIC BUSINESS


- ✚ Zoneton Fire Chaplin, Joe Wells spoke about the salaries of the Bullitt County Constables are not paid what they say they are on the internet. The Constables barely receive enough money to cover the cost of fuel. They are responsible for the cost of their training, certifications, vehicles, and equipment needed.




ADJOURNMENT

- ✚ Commissioner MacIntyre made a motion to adjourn the meeting. Commissioner Israel 2nd the motion. All were in favor. Motion Carried.


