
COUNCIL BUSINESS

- ✚ Commissioner MacIntyre said that Larry Watkins is running for Constable.


ADJOURNMENT

- ✚ Commissioner MacIntyre made a motion to adjourn the meeting. Commissioner Israel 2nd the motion. All were in favor. Motion Carried.


