Quorum determined and meeting called to order at 7:05pm by Mayor Ross

- ✚ Clerk Steele read the meeting minutes from August 22, 2022. Commissioner Israel made a motion to accept the regular minutes as read. Commissioner Parker 2nd the motion. All were in favor. Motion carried.


OLD BUSINESS

- ✚ Attorney Edison explained the rate calculation worksheet. The City must have a public hearing if rate is set between 9.196 and 9.466% per hundred. Commissioner Israel made a motion to set the 2022 Real Property tax rate to 9.466% per hundred. Commissioner Parker 2nd the motion. All were in favor. Motion carried.
- ✚ Attorney Edison read the 2nd reading of Ordinance 2022-04 Real Property AdVal Tax. Commissioner Parker made a motion to adopt Ordinance 2022-04 Real Property AdVal Tax. Commissioner Israel 2nd the motion. All were in favor. Motion carried.
- ✚ Attorney Edison explained that the Personal Property and the Public Service Co Adval Tax rates must be set to the same rate. Commissioner Parker made a motion to set the 2022 Personal Property and Public Service Co AdVal tax rate to 15.760% per hundred. Commissioner Parker 2nd the motion. All were in favor. Motion carried.
- ✚ Attorney Edison read the 2nd reading of Ordinance 2022-05 Personal Property AdVal Tax. Commissioner Israel made a motion to adopt Ordinance 2022-05 Personal Property AdVal Tax. Commissioner Parker 2nd the motion. All were in favor. Motion carried.
- ✚ Attorney Edison read the 2nd reading of Ordinance 2022-06 Public Service Companies AdVal Tax. Commissioner Israel made a motion to adopt Ordinance 2022-06 Public Service Companies AdVal Tax. Commissioner Parker 2nd the motion. All were in favor. Motion carried.
- ✚ The Mayor asked the Commissioners if they were interested in an ordinance to prevent solicitors in the city. The Commissioners and Mayor decided that each homeowner would be responsible for their own actions on solicitors.
- ✚ Commissioner Israel add to motion for Ordinance 2022-04 Real Property and Ordinance 2022-05 Personal Property AdVal Tax to be published in summary.


ADJOURNMENT

- ✚ Commissioner Israel made a motion to adjourn the meeting. Commissioner Parker 2nd the motion. All were in favor. Motion Carried.


