- ✚ Clerk Steele read the meeting minutes from August 16, 2022. No vote needed, no meeting.


NEW BUSINESS

- ✚ Commissioner MacIntyre made a motion to adjourn the meeting. Commissioner Israel 2nd the motion. All were in favor. Motion Carried.


