All recited the Pledge of Allegiance

- Clerk Steele read the meeting minutes from October 17, 2023. David Lotze made a motion to accept the regular meeting minutes as read. Linda Parker 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- David Lotze made a motion to accept the financial report from October 31, 2023. Linda Parker 2<sup>nd</sup> the motion. All were in favor. Motion Carried.

## OLD BUSINESS

- ✚ Website -Chad Mallory said we need to move forward to look for another website host. Mayor asked for prices. Chad Mallory said he will bring to next meeting.
- ✚ Street Sealcoat Estimate- Mayor still waiting on return calls.
- ✚ Regulations on Animals- Attorney Edison stated that we have an Ordinance in effect that defines the care of any animal. Ordinance 985-XVI from 1985 and Ordinance 2016-05. Mayor stated that the two ordinances cover for any violation in the City.

## NEW BUSINESS

- ✚ Santas Helper PV -Deputy Clerk McCauley explained any donation would help the children in the neighborhood with Christmas. Susan Mallory made a motion to donate \$500.00 to Santas Helper. Chad Mallory 2<sup>nd</sup> the motion. All in favor Motion passed.
- ✚ Linda Parker asked if he has donated to anything else in the City's name. Mayor said he donated bikes to United Way. Attorney Edison stated that you usually donate money and let the company spend on what they need. Usually, the Council approve what to donate. Mayor said he would reimburse the City for the bikes

- ✚ David Lotze would like to look into the Bee Pollination for a part of the common area. Susan Mallory had put out emails and is waiting for replies.
- ✚ David Lotze put in work orders on light poles number 115 & 117.
- ✚ David Lotze would like to look into the cost of an additional light pole to be put up on Angelina Road by Salt River.
- ✚ David Lotze stated that his neighbor does concrete work and would like to get a price for fixing the sidewalks.
- ✚ David Lotze said some of the culvers on the city streets are damaged or blocked. Mayor said we have to identify the areas and get a price David Lotze will walk the area and let us know.
- ✚ Linda Parker asked about the Cannon Court Ditch repair. Mayor read the email from Steve Emily concerning the stream bank. If it falls under the NWP Blue Line Stream then if the Corp says yes then we have to get permit and comply with the City and County laws.
- ✚ David Lotze asked about snow removal. Mayor said it will be on a case-by-case basis. The Mayor will look into vendors.

- ✚ Linda Parker asked about the insurance papers from the tree trimming company. Mayor stated no response yet.
- ✚ Mayor said if the meetings are moved to Mondays, he will not take a salary and donate it back to the City.


